Introduction

We are looking forward to welcoming your Learning group to the National Motor Museum and Beaulieu.

The enjoyment of groups and the health and safety of all our visitors is one of our main priorities.

This pack/information is designed to help you to complete a comprehensive risk assessment for your visit.

Risk Assessment

Group leaders are advised to visit the venue in advance of their Learning visit in order to conduct their own risk assessment. We are happy to offer this free of charge. To arrange your free pre-visit, please email Education@beaulieu.co.uk to arrange a date and time.

This pack/information does not qualify as a Learning group completing their own risk assessment. It is the responsibility of the Learning group to complete their own risk assessment visit ahead of their scheduled group visit. The following risks should be considered when completing a risk assessment:

- Slipping, tripping, or falling on entry to the Collections Centre, Museum, Abbey, Palace House and within buildings or the grounds;
- Slipping, tripping, or falling due to liquid, e.g., water leaks and spillages;
- Vehicle movement around the estate, bus rides and monorail rides;
- Sustaining light injury (for example cuts and bruises) through collision with display cases, static vehicles on display and corners;
- Sustaining light injury (for example cuts and bruises) in the play area "Little Beaulieu"
- Trapping fingers in doors, including lift doors and vehicle doors (when accessible);
- Being separated from the rest of the group;
- Sufficient first aid arrangements within your own group;
- Lost children;

The Learning team should be made aware of any pre-existing medical conditions of group members, staff, and accompanying adults before visiting.



We encourage that your own risk assessment is undertaken in accordance with <u>HSE Guidance</u> for school trips.

Fire and evacuation

- The Beaulieu attraction, the National Motor Museum and all Learning areas have full evacuation procedures in case of emergency or fire. All fire exits are clearly marked, and all staff have received training in evacuation procedures.
- Our security, fire and safety procedures are assessed on a regular basis and are updated as necessary.
- An uninterrupted alarm is used to alert staff and visitors of an evacuation.
 In the event of a fire evacuation, lifts should not be used, and staff will direct you to a place of safety
- Once outside, move away from entrances to enable the escape of others.
 You will be directed to our Assembly Area by a member of staff wearing a hi-visibility vest
- Group leaders should take the register and report any missing persons to a member of staff (who will either be wearing a National Motor Msueum badge, a Beaulieu uniform, or a hi-visibility vests). Please ensure that your group understands the importance of following such procedures in the event of an evacuation.

First aid

- Beaulieu, the National Motor Museum, and the Learning department have members of staff trained to provide basic first aid treatment, although first aid provision is ultimately the responsibility of the group leader, who must carry first aid supplies at all times.
- Please report any accidents to uniformed Beaulieu staff, or anyone wearing a National Motor Museum lanyard and name badge, who will be able to call for the First Aider.



Museum & Learning staff

- All museum and learning employees are passed through the vetting system
- Learning staff wear National Motor Museum lanyards with name badges so they can be recognised by visitors, museum staff wear identifiable uniform
- All staff leading sessions are experienced in working with young people, school groups or people with additional needs. Staff have undertaken relevant safeguarding training

Supervision and behaviour

- Responsibility for visiting group members remains with the group leaders at all times
- Group leaders should remain with their group members at all times and ensure they are accompanied in the event of evacuation.
- Groups must have the correct leader to group members ratio:
- I. for children in primary level education, 1 supervising adult for every 5 children;
- II. for students in secondary level education, 1 supervising adult for every 10 students;
- III. for students in higher level education, 1 supervising adult per group.
- IV. These numbers may alter if your choice of visit demands smaller breakout group work, and you will be notified of this at the time of booking
- The Learning department reserve the right to refuse admission to groups who are not considered to have sufficient adult supervision.
- Any Learning department staff member present during a Learning visit DOES NOT count for the purposes of the above table and we reserve the right to refuse to conduct a Learning visit where these supervisory levels are not met.
- If the behaviour of any groups or individuals affects the safety or enjoyment of other visitors, they will be asked to leave. Group leaders should ensure that their group understands how they are expected to behave and have contingency measures in place in the event that anyone is asked to leave.



• Group members should be instructed to inform a uniformed member of staff or a member of staff wearing a National Motor Museum lanyard and name badge should they become separated from the rest of the group. Please ensure all group members and accompanying leaders are made aware of this in advance of their visit.
Students should not be left unsupervised at any time within our Grounds. Beaulieu and The National Motor Museum do not accept the role of in loco parentis. The Learning team are obliged to report to the associated school/college and education welfare officer at the associated local authority should any there be any incidents of negligence on part of group visiting.

Arriving at Beaulieu

- Free coach and minibus parking is available in our carpark, please follow the signs
- There is a bus stop just before the coach parking which serves as a coach drop off and pick up point if schools wish to avoid crossing the road on arrival
- The Visitor Reception entrance is step-free and wheelchair accessible
- For those groups visiting the Collections Centre there is a "VIP" accessible entrance reserved for school groups and separately accessed. A member of the Learning team will escort groups through that entrance
- Upon arrival you will be met by a member of the Learning team and escorted to the Learning space reserved for your programme
- Beaulieu has a single point of entry for visitors but multiple venues for Learning within the estate, please familiarise yourself with the map below to see where your programmes will take place

Toilets

The Collections Centre Learning space has access to designated WCs for males and females, as well as designation of an accessible WC which can be used by any gender. These toilets are not open to the public but can be used by staff in the Collections Centre.

Within the estate there are a variety of public toilets available for groups to use. The Brabazon, the Abbey and Little Beaulieu all have accessible toilets which are also open to the general public

Children should be escorted to the toilets in the presence of a group leader from the school.



Facilities for Learning groups

There are two main classroom areas on site:

- I. The fully accessible Collections centre Learning space which includes our Education room and Lecture Theatre. This area has access to multiple toilets, including accessible toilets, which are not open to the public but can be accessed by staff in the Collections Centre. These are regularly cleaned throughout the day
- II. The Garden Classroom space which is central to the attraction and provides step free access

The Learning team can provide a lunchroom facility where your group can eat packed lunches. Please ensure that waste is put into the bins and that you spray and clean tables after use. During the warmer months there are picnic tables available to use throughout the attraction, for warm but wet days there is a tented area available for groups to use. Please be aware that all covered areas should be booked in advance

Consuming food and drink in any exhibition area (the National Motor Museum, the Abbey, Palace House, or SOE) or the Lecture Theatre is strictly forbidden

Please do not bring large bags and be prepared to keep your bags with you at all times in the interest of safety and security. Depending on the programme booked the Learning team will advise if an area for bag storage is available on the day.

The Learning department do not provide smoking facilities, and promotes the Government's aim to a <u>smoke free generation</u>


Should your group require an area of contemplation, the Learning team is able to facilitate this if requested in advance.
